

GSEF2018 in brief

The Global Social Economy Forum — GSEF 2018 is the fourth edition of this forum, that was initiated by the City of Seoul in 2013, in collaboration with its local social economy partners. The 2014 edition, held once again in the South Korean capital, culminated in the founding of the GSEF as a permanent international association uniting local governments and civil society stakeholders that recognize the Social Economy as a key factor in local economic development.

In 2015 Bilbao became part of the GSEF network

The third edition was celebrated in 2016 in the city of Montreal, where it was announced that Bilbao would host GSEF 2018

In February 2017 the Local Organizing Committee was created, which under the Councillorship of Economic Development, Commerce and Employment and alongside GSEF, has been the organ designing GSEF 2018. This Committee has been formed by Public Institutions and the representative entities of Social Economy.



The Forum's main theme was agreed among all the members of the Local Organizing Committee:

Social Economy and Cities

Values and competitiveness for inclusive and sustainable local development

Besides the entities and institutions of the Local Organizing Committee, a key role in GSEF 208 has been played by the University of the Basque Country, the University of Deusto and Mondragon University

INTERNATIONAL CALL

From 20 December 2017 until 23 March 2018, there was an international open call to submit initiatives or projects of Social Economy

A total of
560 initiatives
were received from 64
different countries

PROGRAM

- 5 plenary sessions, where a total of 31 public figures have intervened: local authorities, representatives of the European Commission and of entities and international networks of Social Economy. All of them, coming from 4 continents to debate and give testimony for Social Economy as a leverage of a more egalitarian and sustainable social and economic development.
- 29 workshops, distributed in 9 workshop sessions where 102 initiatives have been presented, selected among the nearly 600 received during the international open call. Over half of the presented initiatives were locally produced.
- 4 themed workshops organized by the GSEF network itself.
- 2 workshops organized by the European Commission.
- 7 workshops organized by international entities: ILO, OCDE, UNRISD, Fair Trade/WTO, RIPESS, UCLG, INAISE.
- 37 initiatives submitted in poster format.
- 11 field visits: 495 people participated and 32 local companies leading in Social Economy were visited.
- 3 side-events organized by GSEF partners, and 2 publishing of reports on a European level.
